CODES OF PRACTICE (CoP)

- To harmonise the industry practices related to food safety, quality and sustainability
- To provide the industry – alternative auditing scheme to RSPO, ISCC – cost of implementation can be burdensome
- Platform to new sustainability standards, MSPO
- To benchmark oil palm products for food safety, quality and sustainability » leading to certification.

To improve the yield of fresh fruit bunches (FFB), palm oil quality and oil extraction rate (OER), MPOB had developed certification scheme that will assist in sustaining:

1. Quality
2. Food Safety
3. Environment
4. Social Responsibility

The Codes of Practice provide guidance to maintain food safety, quality and sustainability along the oil palm supply chain. The certification includes:

1. Oil Palm Nursery
2. Oil Palm Estates and Smallholdings
3. Palm Oil Mills
4. Palm Kernel Crushers
5. Palm Oil Refineries
6. Handling, Transport and Storage of Products from the Oil Palm
